# Item No.3: To consider the proposal of Balasaheb Thackeray Law College, Panvel (LLB3008) to open the online link for submission of proposal for the academic year 2024-2025.

"The following were present:-

The Incharge Principal of the Institute/College submitted that the fees of their Institute/College was approved for the academic year 2021-2022. Since thereafter the Institute/College has directly submitted proposal for the academic year 2024-2025. The Institute has continued to charge the fees approved for the academic year 2021-2022 for the academic year 2022-2023 and 2023-2024. The Management of the Institute was acting under the impression that as the Institute/College is not seeking upward revision of fees the proposals is not required to be submitted for the academic year 2022-2023 and 2023-2024. Only after the show cause notice was issued the Institute realised that the proposal was required to be submitted for the academic year 2023-2024 and Institute was entitled to opt for no upward revision of fees for the academic year 2022-2023. The mistake was occurred as the earlier Principal has left the Institute/College. The Principal of the Institute/College submitted that Institute is desirous to continue to apply the fees structure approved for the academic year 2022-2023 and requested to allow the Institute to submit the proposal for the academic year 2023-2024 by opening link. She further submitted that the fees to be approved for the academic year 2023-2024, the Institute will opt for no upward revision of fees for the academic year 2024-2025. The letter of request submitted by the Incharge Principal taken on record.

Considering the reasons assigned it was decided to allow the Institute to submit the proposal. The Institute is allowed to opt for no upward revision of fees for the academic year 2022-2023 and submit the proposal for the academic year 2023-2024 subject to penalty of Rs. 1,00,000/-. The deposit of penalty to act as condition precedent to entertain and decide the proposal. After the proposal submitted by the Institute and same is decided, the Institute will be at liberty to opt for no upward revision of fees for academic year 2024-2025 by informing the Authority to that effect in writing.

The link be made open w.e.f 29/08/2024 and same to remain open till 18/09/2024. The hard copy of the proposal be submitted within one week from the date of uploading the online proposal.

The Principal of the Institute/College submitted that their Institute got permission to start the M.Sc (Nursing) course from the academic year 2020-2021. But in the academic year 2020-2021 the Institute/College could not admit students due to late permission from the Competent Authority. The Institute has admitted first batch of students in the academic year 2021-2022. The Institute has charged the adhoc fees in the academic year 2021-2022 and 2022-2023 to the batch of students admitted in the academic year 2021-2022 and 2022-2023. The Institute ought to have submitted the proposal for the academic year 2023-2024. Inadvertently same was remained to be submitted. The Institute has submitted the proposal for the academic year 2024-2025.

The Principal of the Institute was explained that in terms of sec 14(1)(a) of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees)Act, 2015, the Institute was under obligation to submit the proposal either in academic year 2022-2023 or atleast in 2023-2024 & confirmation and finalization of fees for the academic year 2021-2022 & 2022-2023. Unless the fees of the academic year 2023-2024 and adhoc fees of earlier two years are finalized the proposal of Institute for academic year 2024-2025 cannot be finalized. The Principal of the Institute conceeded that there was a mistake on the part of the Institute and requested to allow the Institute to submit the proposal for academic year 2023-2024 and adhoc fees for academic year 2021-2022 & 2022-2023. The Principal of the Institute is directed to submit the letter to open the link for academic year 2023-2024 and confirmation of adhoc fees for earlier two years. The Principal of the Institute submitted that she will appraise the Management of the Institute & thereafter submit the letter as directed. The necessary action on the part of the Institute be taken within one week. Incase the letter of request is received same be processed.
